A decision has been taken by the appropriate authorities regarding the granting of permission to use logos at Dhaka and Aricha and Daulatdia river ports/ wharves subject to the following conditions:

- (a) Other than the monogram/logo of BIWTA and Development Activities of Society (DAS) on stickers. No monograms/logos may be used;
- (b) BIWTA shall not have any financial involvement in it.
